Admissions information

Information about the admission of part-time students is available via the Adult Education area of the College website, the termly prospectus, further detail sheets and from Adult Education staff (comprising the Adult Education administrators, coordinators and tutors and the Director of Business and Finance).

The website and prospectus lists the range of courses available, indicates progression routes and details payment options. Prospective students are directed to the website in the first instance although printed copies of the prospectus are also available from the Adult Education Office and at the Cambridge Leisure Park. They are also hand delivered locally by a distribution company.

The further details sheets are available on the website with printed copies situated outside the Adult Education Office. They provide specific details about course content, tutor profile, learning outcomes, dates, times and mode of assessment (if applicable). Guidance is available in relation to entry requirements (if required).

General entry requirements

Students should:

- demonstrate suitability and motivation for the course
- be capable of payment of tuition and other fees, where applicable
- comply with the expectations found in the Adult Education students Code of Conduct, available on the website
- be aware of issues relating to disabled access and the support of adult students with learning difficulties, where applicable

Admission priority

The prospectus for the following term is distributed to existing students during class, to give them the opportunity to enrol, ahead of the main distribution. This is to ensure that those part-time students following a progression route can enrol on the next course.

Other part-time students are admitted to the College in order of completion of enrolment and fee payment.
